The exhibition will be on display Tuesday, April 26, 2022, to Tuesday, May 31, 2022.

Award winners will be announced during the **First Friday Opening Reception**, May 6, 2022, at 5:30 p.m. and will be shared on the Arts Rolla Facebook page. Award recipients will also be listed on the Arts Rolla website, www.artsrolla.org. Award recipients unable to attend the reception will be notified by email on Monday May 09, 2022. Awards will be available after May 31, to artists unable to attend the reception.

Photographs must be picked up **May 31, 2022** between the hours of **10 a.m. to 2 p.m.** at The Centre, 1200 N. Holloway St. Rolla MO 65401.

Juror/Judge: Photography will be juried and judged for this show.

Judge: Karen Glines

BIO: Being an artist requires perseverance, fortitude, and passion. Whether taking photos, teaching, writing, editing, or creating publicity campaigns, I have experienced each emotion time and again. My photos have appeared in *The St. Louis Post Dispatch* and numerous other newspapers and magazines. Perhaps being the photojournalist for the innovative "Artists Along the Katy Trail" project, where I interviewed and took photos of hundreds of artists across Missouri for two years, has remained a highlight in my career.

As the first St. Louis Culture and Arts writer/photographer for America Online, I received a first place award for "Digital City St. Louis." In addition, the uploaded day-to-day pictorial history of "Artists Along the Katy Trail" onto its website won a first place national award. Awards are humbling such as the Quest Award from National Federation of Press Women and the Governor's Award by the Missouri Humanities Council in Literary Achievement for the book, *Painting Missouri: The Counties en Plein Air* (www.paintingmissouri.com). However, teaching and viewing the work of other dedicated artists, such as in this exhibit, remains paramount to me.

Conditions of Entry:

1. **Age:** 18 and older
2. In order to be considered for recognition and awards **all photographs must be submitted with a completed entry form and entry fees**, on **Tuesday April 26, 2022- between the hours of 10 a.m. & 2 p.m.** No photos will be accepted after **2 p.m. on April 26, 2022.**
3. Each photographer may submit a **maximum of 3 framed and wired photos.** Entries may not be larger than 36" x 36" or 144" total.
4. **Entry Fee:** all Entries along with completed forms must be received **on April 26, 2022. By 2 p.m.**
5. All photographs must be picked up on **Tuesday May 31, 2021 by 2 p.m.**

All entry fees are payable to ARTS ROLLA and are non-refundable.

ARTS ROLLA Members - \$15.00 **Non-Members - \$30.00.**

In order to utilize the discount on the entry fees, artists may join ARTS ROLLA

On April 26, 2022 when entering the show. Membership fee is \$25.00.

All Entry fees will be used for the expenses and awards for the 28th Annual Judged Photography exhibit.

Guidelines for Entries:

1. All categories of photography may be submitted for consideration, except photographs previously submitted in ARTS ROLLA competitions. Entries must be within the last Five years and original work of the exhibiting photographer. (Tasteful boudoir photography will be accepted).
2. **Juror/Judge determines awards. All photographs will be given an entry number before the Juror/Judge arrives. Judging is anonymous. (if your artwork is signed the signature will be covered prior to the judging).**
3. **ALL** items must be wired on the back and labeled as indicated below. NO duct tape or Sawtooth hangers will be allowed.
4. **ALL** entries to be on display at the Centre must be no larger 36" x 36" each photo must be labeled on the back, with the photographer's name, title of the photograph, contact phone number, and the year the photograph was taken.
5. Photographers may submit up to 3 photographs. To be eligible for entry and awards the Photographs may not have been previously submitted in Arts Rolla's Judged photography exhibits.
6. **Sales:** Photographers are encouraged to price their work at their established market price. This price may not be altered during the run of the show. All sales must be transacted between the buyer and ARTS ROLLA, who shall retain a 20% commission.
7. Photographs not picked by **2 p.m. on May 31, 2022** will be charged a \$10.00 handling fee. Photographs no collected by **June 28, 2022** become the property of Arts Rolla.

Agreement: ARTS ROLLA assumes the right to use any image submitted for educational and/or publicity purposes, which includes display of the image on the Arts Rolla Website and Facebook as part of the virtual photography show. The receipt of an entry will be understood to imply agreement on the part of the photographer with all of the conditions mentioned within this invitation.
