Completed Entry forms for ALL photographs, must be submitted in person on Tuesday April 28, 2026, between the hours of 10 a.m. to 2 p.m. at The Centre, 1200 N. Holloway Street, Rolla MO 65401.

Entry Fees can be paid with cash or check the day of submission, April 28, 2026.

The exhibition will be on display Tuesday, April 28, 2026, to Tuesday, May 26, 2026.

Award winners will be announced during the **First Friday Opening**, May 1, 2026, at 5:30 p.m., shared on the Arts Rolla Facebook page, and also listed on the Arts Rolla website, www.artsrolla.org. Award recipients unable to attend the reception will be notified by email.

Unsold photographs must be picked up **May 26, 2026** between the hours of **10 a.m. to 2 p.m.** at The Centre, 1200 N. Holloway St. Rolla MO 65401.

Juror/Judge: Photography will be judged for this exhibit by Doug Budd.

“I’m an award-winning photographer who got my start in 1988. I graduated from the New York Institute of Photography in 1999. Over the years I have worked in many different areas of photography. I have shot weddings, school yearbook photos, and senior pictures. I have been published in multiple newspapers, including seven front pages. I have shot model portfolios that ended up in the Ford Modeling Agency. I have also done product/catalog photography. One of my favorite types of photography that I have done is concert photography, including all access backstage.

For relaxation, I enjoy landscape and macro photography. I have won awards for my macro work and landscape work.

My influences in photography are William Henry Jackson, Edward S. Curtis, Ansel Adams and Edward Weston.”

Conditions of Entry:

1. **Age:** 18 and older
2. In order to be considered for recognition and awards **photographs must be submitted with a completed entry form and entry fee on Tuesday, April 28, 2026 before 2 p.m.**
3. Each photographer may submit a **maximum of 3 framed, wired and labeled photos.** Entries must be smaller than 36” x 36” or 144” total.
4. **Entry Fee:** All entry fees are payable to ARTS ROLLA and are non-refundable.
ARTS ROLLA Members - \$15.00 **Non-Members - \$30.00.**
Photographers may become members of ARTS ROLLA at the time of registration to receive the discounted entry fee.
5. Unsold photographs must be picked up on **Tuesday May 26 by 2 p.m.**

Guidelines for Entries:

1. All categories of photography may be submitted for consideration, except photographs previously submitted in previous Arts Rolla competitions. **Entries must be within the last three years and original work of the exhibiting photographer.**
2. **Juror/Judge determines awards.**
3. **ALL** items must be securely wired on the back and labeled as indicated below. **Absolutely NO duct tape or Sawtooth hangers can be allowed.**
4. Photographers may submit up to 3 photographs. To be eligible for entry and awards the photograph may not have been previously submitted in Arts Rolla’s Judged photography exhibit.
5. **Sales:** Photographers are encouraged to price their work at their established market price. This price may not be altered during the run of the show. All sales will be transacted between the buyer and ARTS ROLLA, who shall retain a 20% commission.
6. Photographs not picked by **2 p.m. on May 26, 2026** will be charged a **\$10.00** handling fee. Photographs not claimed by **June 24, 2026** become the property of Arts Rolla.

Agreement: Arts Rolla assumes the right to use any image submitted for educational and/or publicity purposes, which includes display of the image on the Arts Rolla Website and on Facebook as part of the photography show. **The receipt of an entry will be understood to imply agreement on the part of the photographer with all of the conditions mentioned within this invitation.**
